Raphael 2: yes

Stephanie Perrin: ICANN staff and legal would be (IMHO) legally prevented from helping....potential conflict

Rafik: I can Paul Diaz again how RySG did in term of incorporation

Raphael 2: yes that would be good

Stephanie Perrin: That would be great! They pay fees though, right? the BC does...

Rafik: BC was keen because they had for many years issues regarding managing memberhsip fees as ICANN refused systematically to handle that on their behalf

Rafik: yes all of other SG/C have membership fees

Stephanie Perrin: Exactly, and correctly too,

Stephanie Perrin: I don't have that request for ICANN 63, do you have it handy?

Maryam Bakoshi: I will send it to you Stephanie

Stephanie Perrin: Thanks Maryam!

Maryam Bakoshi: Hi all, I have pasted the agenda on the Pod to the right

Maryam Bakoshi: Please let me know if you see it

Stephanie Perrin: Got it, thanks!

Stephanie Perrin: who did we lose?

Raphael 2: maryam?

Raphael 2: yes

Raphael 2: Maryam is gone

Maryam Bakoshi: Dialling back in

Stephanie Perrin: WE need to get those ABRs in soon, Maryam do you remember the deadline offhand? Coming up soon

Rafik: pretty soon

Rafik: we are already 1hour in the call, hope just we touchbase about the public comments soon

Rafik: lost audio?
